Great, great emotions that you are expressing here. Good to hear that.

Program exists is because we wanted to make sure that there was a place for LGBTQ survivors to, to be able to meet with

other LGBTQ advocates, and especially in the BIPoC Community. And our staff at the Anti- Violence Program. We have five people,

83

myself and, and four advocates, and of the five, four of us are identified as BIPoC, two black, queer folks in Milwaukee,

84

and then three of us up here in Appleton. We think it's very important to have representation in our work, and we want to make sure

85

that survivors know that when they... survivors and advocates know that when they call our program, we come at it from the approach of

making sure that we're serving the people who have been historically excluded from justice.

87

So, thank you for those, those great emotions and feedback.

88

You know in the film somebody, a survivor, mentioned that they couldn't talk to friends or family and that is certainly something

89

we hear, you know, working with survivors of intimate partner violence, and this person said, "because he wouldn't let me."

90

And in the chat I'm going to ask you just to throw some answers out, but what are some other reasons, what are three reasons, I guess,

91

but you can just give out whatever reasons that an LGBTQ survivors specifically brown, black, indigenous may not be able

92

00:28:49,034 --> 00:28:55,199

to talk to their frien... family or friends about abuse that might be different than Heterosexual people... umm, Cisgender,

93

00:28:55,200 --> 00:29:01,034

Heterosexual people experiencing violence. Yes, fear of being outed. Yes, they're not out yet.

94

Absolutely. Yes. Culture. Yes. Taboo, judged, won't be believed.

95

People brush it off, shame, religion. Y'all going to... y'all are answering, and I didn't... I thought that we were gonna have to warm up!

96

Let me go back up a little bit. Isolation from their community. Partner could turn their fellow LGBTQ friends against them.

97

00:29:23,800 --> 00:29:30,034

Yes, that's very good point, very key. HIV status. I don't want to miss any here.

98

A lack of acceptance within the community. Yeah, lack of acceptance from both within the LGBTQ Community about this type of violence.

99

Often, when we're talking with LGBTQ folks, it's very, it's often easier for us to talk about the, the, the oppression,

100

00:29:47,800 --> 00:29:54,666

and people causing violence from the outside to our community, but it is really not.

101

00:29:54,666 --> 00:30:00,832

It isn't always easy to talk about the oppression within our community, and it's, it's that internalized response, right, to oppression, and

102

00:30:00,833 --> 00:30:07,533

that is something that the Women of Color Network advocates. Talk about is that internalized response not internalized

103

00:30:07,533 --> 00:30:14,783

homophobia and not internalized racism because that that puts the onus back on the survivors so it's our internalized response to

104

00:30:14,783 --> 00:30:22,033

that, to that oppression so HIV status stigma around who was harmed, and who is the harm doer.

105

00:30:22,034 --> 00:30:32,033

Yes. Not feeling accepted. They do not want to be shamed, isolation, worried about perceptions, stigma. You all are doing great.

106

00:30:32,033 --> 00:30:44,066

Lack of acceptance. Family is, isn't supportive, weaponize, depression, identities, lack of support. Well, as you all can see rejection.

107

00:30:44,066 --> 00:30:49,932

They're not out about their HIV status, concerned about credibility,

108

00:30:49,933 --> 00:30:56,133

They may be the only LGBTQ person that friends and family know, and therefore, they're worried about painting a negative picture on

00:30:56,133 --> 00:31:04,366

the whole community. Yes. They worry about not being believed, the assumption is that there are no power imbalances within

110

00:31:04,366 --> 00:31:10,667

the LGBTQ relationships. Oh really, good point that is, that's a, that's a really good point.

111

00:31:10,667 --> 00:31:14,466

They're may be only LGBTQ person that friends and family know,

112

00:31:14,466 --> 00:31:19,667

and therefore, they're worried about painting that negative picture again for the whole community.

113

These are great, and I'm trying to get as many answers in as I can because I know we're recorded but,

114

00:31:24,466 --> 00:31:33,667

shame, again, and misconceptions, their status about transition and medical procedures, things like that.

115

Yeah, so really you have answered all of the reason and then some, the reasons that we were going to talk about,

116

but not being out about identity is, is a, is a big thing that still happens in 2021. Or, you know, individuals can have their lives are ruined

117

by having somebody out them as a trans person, out them as a LGB person, lesbian, gay, or bi person, depending on what their

118

00:32:00,800 --> 00:32:09,500

career is and just in the community support in general. So, we are grateful that you gave such great feedback. I'm sorry if I didn't

So the next question, one of the survivors stated that they felt kidnapped for five years after they survived an abusive relationship.

And so, my question to all of you. If an LGBTQ survivor feels trapped in an abusive relationship,

what are some unique barriers a survivor might face if they want to leave?

123

And again, I invite you to put some of your answers in the chat.

124

Lack of resources, financial barriers, lack of support, difficulty finding a safe community.

125

And, I'm really glad to hear that someone acknowledging limitations that might exist at shelters.

126

There's an additional layer of barriers for folks in rural situations who, whether that's transportation and also lack of,

127

and what sorts of resources available with the added layer of being maybe a very isolated in their identity.

128

Lots of answers coming through here. Some other things might be being part of a

129

00:33:37,333 --> 00:33:45,399

smaller community. In our earlier conversation with Kathy's last question,

130

00:33:45,400 --> 00:33:52,667

people talked about feeling protective over the LGBTQ Community.

131

00:33:52,667 --> 00:34:02,667

The survivor may not, may worry that their abuse may not be taken seriously because of their identity.

132

00:34:02,667 --> 00:34:22,667

And, the ways, woo, my chat box is moving so quickly. Umm, not feeling welcome in shelter, uncertainty of future resources.

133

What gender segregated options might be available in a particular shelter. And this often creates barriers for Trans people,

134

00:34:34,900 --> 00:34:51,400

Gender Non-Conforming people, Non-Binary folks, and anyone who is gender diverse or gender creative in their expression.

135

Worrying about access to other types of care, whether that's medical treatment, health resources. All very great answers,

136

00:35:06,466 --> 00:35:13,667

thank you so much, and Kathy I'm going to pass it back to you for the next question.

137

Well, this audience certainly understood the assignment. [Laughing] Could do a TicTok video off of that one.

138

Um, my question is about. So one survivor stated "She used my identity as a way to control me as a Trans person."

139

00:35:28,566 --> 00:35:36,866

They were specifically talking about a Lesbian using her partner's identity as a Transman to emotionally abused him about that identity.

140

What are some ways that Cisgender abusers of intimate partner violence can use abuse tactics,

141

00:35:42,100 --> 00:35:47,566

specifically, to their... about their partners Trans identity?

142

00:35:47,566 --> 00:35:55,966

And before I read some of these off, I also just want to acknowledge that transition deeply impacts relationships, and we know that.

143

There are many deep feelings that will be involved, and we're not addressing about,

144

00:36:02,200 --> 00:36:09,866

we're just addressing about abuse when, when transition happens. Not necessarily relationship dynamics. Some relationships don't make it,

145

00:36:09,866 --> 00:36:15,166

and the ending of the relationship is not abuse, but there is abuse that can happen on the way to that.

146

00:36:15,166 --> 00:36:24,667

So let me... I'm going... actually, what I found out to be the best is when I put my chat screen on big so then I can see all the way up.

147

00:36:24,667 --> 00:36:36,667

So some things to answer this question,

148

00:36:36,667 --> 00:36:43,866

Saying that you're not a real man or a real woman. Absolutely. Outing them again as a Trans person, right.

149

00:36:43,866 --> 00:36:49,466

Threats of outing their intimate partner. Diminishing their gender identity. Yes.

150

00:36:49,466 --> 00:36:57,032

Denying their gender expression or claiming that it isn't legitimate. Partners knows... Yes, partner know all their vulnerabilities, and

151

00:36:57,033 --> 00:37:11,667

therefore, can, can play on them. Power and control. Withholding medication, Yes. Medical care and transition. "Nobody else will love you."

152

00:37:11,667 --> 00:37:20,532

Withholding access to transition, medication. Gaslighting of gender, not validating their emotions, taking away medical access.

153

00:37:20,533 --> 00:37:27,833

Using Transness as a threat. In other words, as someone... They will never find someone who accepts them.

154

00:37:27,833 --> 00:37:36,633

And the quote is "Well, I'm not [and put in the sexual descriptor here] so if you transition, we can't be together."

155

00:37:36,633 --> 00:37:42,667

So oh, because I'm not a gay man, or a lesbian, or something like that.

00:37:42,667 --> 00:37:49,667

So blaming the other person about how it changes... how they are trying to express that it changes their identity.

157

00:37:49,667 --> 00:37:58,399

Yes, yes, yes. Using law enforcement against the Trans survivor. Threatening to tell Child Protective Services, oh my goodness, yes!

158

00:37:58,400 --> 00:38:04,733

Away from Trans parent, Taking the child. Isolating Trans survivors from Cisgender family. I just want to take a note on that.

159

00:38:04,733 --> 00:38:11,733

That is so true. We work with the family court system. And not only is the identity of a Trans

160

00:38:11,733 --> 00:38:17,566

person in relationship and partnership, using the court system to take children away.

161

00:38:17,566 --> 00:38:22,166

But when a Trans child comes out to their parents, and there's an accepting parent and the abusing parent, who might have also been

162

00:38:22,166 --> 00:38:33,966

abusive to the parent, who, who is the accepting of the youth with the... with the trans... accepting of the Trans youth might also

163

00:38:33,966 --> 00:38:42,932

be abusive in that situation. So what we have seen is that... we have seen judges actually say the words "Well, do you really want your

164

00:38:42,933 --> 00:38:49,667

six-year-old boy, and they misgender the child, to wear a dress?" Is that what you're saying?"

165

And using the acceptance of the Trans child against the parent to give custody to the non- accepting trans person so that they can instill

166

00:38:55,366 --> 00:38:58,299

And using the acceptance of the trans child against the parent to give custody to the non- accepting trans person so that they can instill

167

00:38:58,300 --> 00:39:06,100

gender storm... gender norms and stereotypes. So, I just wanted to make sure I took took that up and talked about that a little bit because

168

that is something that we are certainly seeing in the court systems, and things that you will see working with survivors,

169

00:39:11,733 --> 00:39:19,233

who are leaving abusive relationships. And, if they come into the shelter programs and have a youth who might be Trans or Gender

170

Non-Conforming, and that parent who is also abusive to the... to their... to the parent, might need extra support, Diverse & Resilient is here

171

00:39:26,766 --> 00:39:33,667

to help work with that too and within a court systems. So, thank you for that answer.

172

Making victim feel guilty for their choice to transition "How do you think it will feel when..."

173

00:39:38,667 --> 00:39:45,799

"So how do you think it will feel when we're in the community, and people know that you're my partner?" Constantly using a partner's dead

174

00:39:45,800 --> 00:39:58,667

name, yes, or incorrect pronouns. Using their family or children against them for transitioning into their true identity. Yes. Umm.

175

00:39:58,667 --> 00:40:05,667

Some straight up BS, yes, I agree. Child alienation. Targeting the victims gender. Absolutely.

176

00:40:05,667 --> 00:40:13,266

These are such great, such great answers. Thank you so much for this. You are all giving such good feedback.

177

As we, Rieko and I, were preparing for this, we wrote a lot of notes.

178

00:40:17,667 --> 00:40:21,599

Because of facilitators worst nightmare is, well not the worst nightmare I suppose.

179

My internet could go out. But is asking, asking a question and just hearing crickets.

180

00:40:27,133 --> 00:40:32,499

So thank you for that. Some other things that, because there were so many, I'm not sure if they were covered, because actually

181

00:40:32,500 --> 00:40:38,533

I was just saying them so fast, but fetishizing somebody about their identity.

182

00:40:38,533 --> 00:40:45,099

So, somebody is transitioning, it's a deeply personal choice, and it comes with a lot of emotions, and fears,

183

00:40:45,100 --> 00:40:50,600

and everything that you can imagine going into transitioning genders, gender identities.

184

00:40:50,600 --> 00:41:01,366

So a partner fetishizing that, and making it about sexual... about their sexual desires and and just, yeah, fetishizing it.

185

Really refusing to use a Trans person's names and pronouns is as big as well that we see.

And then touching body parts. This hasn't been brought up, but touching body parts that a Trans person has already expressed discomfort

187

about, and continuing to insist that, that they want to have sex by fondling those areas. This is something that we hear from survivors.

So for example, top, some people may not be comfortable with having their top parts touched, and they have tell a partner, don't touch this

I don't want anything to do with this. And an abusive partner will not listen to that boundary, and touch that anyway because they want to

190

00:41:37,366 --> 00:41:42,166

have sex like they want to have sex, and at that point, it becomes assault because, right,

191

we need to, we need to respect what people want done and not done to their bodies. Umm, not using gender affirming language to

192

00:41:51,733 --> 00:41:59,566

refer to Trans partner's body. Yes, absolutely. Thank you, Reiko. Oh, I was like Reiko that was really good." Yes, absolutely.

193

Not using the language that the partner uses to, or that the trans person uses for their body and insisting on using other language.

194

00:42:09,667 --> 00:42:15,667

Alright so, you all cover that really well so I'm going to just, oh, let me just check.

Yes, I'm going to go ahead and let the next question go to Reiko.

196

Thank you. So I may not do as great of a job as Kathy has been doing with the, the comments. Because you all are doing amazing,

197

but I will do my best. And our next question is, you know, so there was a part where someone mentioned TERF that's T E R F.

198

So we just wanted to address that. What does that even mean, and how can views be weaponized to oppress transgender people?

199

I'm going to start with some of my own ideas but also invite you all to share some of your thoughts in the chat.

200

So TERF, T E R F, that stands for Trans Exclusionary Radical Feminists. TERFs are people who consider themselves feminists,

201

but they are also interested, and they're... so feminists who are interested in ending the oppression of women. However, their brand of

202

00:43:18,533 --> 00:43:24,667

feminism is not one that includes Transwomen in their definition of "woman."

203

00:43:24,667 --> 00:43:30,667

It's important to remember that this belief is harmful and invalidating to Trans people.

204

00:43:30,667 --> 00:43:40,466

This is an overt form of transphobia, and specifically transmisogyny, as people who

205

00:43:40,466 --> 00:43:46,667

ascribe to this ideology often target Transwomen and Transfeminine people specifically.

206

So remind us all that black and brown Transwomen have been historically excluded, and face some of the highest rates of violence

207

00:43:53,733 --> 00:44:02,633

and discrimination among women, among BIPoC folks, among LGBTQ folks, and TERF views are... can be used to create even more

208

00:44:02,633 --> 00:44:10,433

barriers to Transwomen to access shelter, support for survivors, health care services,

209

00:44:10,433 --> 00:44:20,066

safe access to restrooms, participating in team sports. And additionally, the rhetoric used by TERFs is often then adopted or co-opted by

210

00:44:20,066 --> 00:44:29,732

others, who push legislation that not only harms Transwomen, but also, other LGBTQ folks, and BIPoC folks, and Cisgender women,

211

00:44:29,733 --> 00:44:40,667

too, right. So I'm thinking of legislators who will use some of the language that TERFs use to talk about gender.

212

00:44:40,667 --> 00:44:50,667

But these are not people who have the interest of women, all women, at heart, either.

213

So the last thing I'll say about Trans Exclusionary Radical Feminism is just a

214

reminder Transwomen aren't a threat, fighting for their justice is not caused harm to Cisgender Women and Girls.

215

And so again, when we're always centering those farthest from justice that means that we

216

bring along, everyone who's been historically excluded along with us.

217

Thank you, Kathy. Yeah, I'm going to go ahead and just say a couple of comments that I want to highlight.

218

TERFs often frame womanhood is biology... by biological and take issue with more inclusive for terms like pregnant woman, or pregnant person

219

I'm sorry. Offers... Often times refers to Cis... Cisgender or CIS as a slur. Yeah, that's a great, great point.

220

00:45:49,667 --> 00:45:59,499

And I just also want to say that if you consider yourself trans exclusionary, there is nothing radical about your feminism,

221

00:45:59,500 --> 00:46:08,066

and... unless it is intersectional. So if you want to be a radical feminist be intersectional in that, and from Dr. Kimberly Crenshaw.

222

00:46:08,066 --> 00:46:16,766

Once again, to give credit to the black woman who coined that phrase, and made it kind of in the stratosphere of talking about

223

00:46:16,766 --> 00:46:26,667

intersectionality only to go on find it misused, and, and is misappropriated it often times. So thank you for that.

224

Kathy, can I add one more thing. Yeah, I mean the other reason why I think it's so important to bring up in our conversation today is the history

225

of our movement. Also includes some anti... people who would, you know, be part of the antiviolence movement,

00:46:47,833 --> 00:46:58,399

who may hold some these harmful views about gender. And that is, you know, where the history of domestic violence... the history of the

227

domestic violence movements, also and, are bedfellows with where TERF ideologies come

228

00:47:07,766 --> 00:47:19,667

from historically, so just important to think about in our own context. Thank you, very cool. Yes.

229

So at Diversity & Resilient, we center the voices of the BIPOC, black, indigenous, other people of color in our movement work because

230

00:47:28,900 --> 00:47:35,667

we... as we continue to talk about that we know that by centering BIPOC individuals that helps everybody gets served,

231

00:47:35,667 --> 00:47:43,532

so we have been centering white Cisgender heterosexual women in this movement since the inception of the moment.

232

00:47:43,533 --> 00:47:53,699

And often leaving out those, those who have been historically excluded in, in communities and also in our programs, and

233

00:47:53,700 --> 00:48:02,166

our shelter programs. And so, when we think about what we want our world to look like now is that if we're going to end violence, right.

234

Violence against everybody, and violence... gender-based violence, but even if you're saying violence against women,

235

00:48:09,667 --> 00:48:17,632

we have got to get to the root of oppression, which is going to be linked to transphobia, homophobia, biphobia because all of those

236

things also highlight how people should... they try to enforce a gender stereotype on how people should behave. And, ciswomen do not

237

00:48:28,100 --> 00:48:35,233

benefit from that at all either because strict gender roles are used in domestic violence with heterosexual cisqender women,

238

00:48:35,233 --> 00:48:40,667

and so the extreme can happen against transpeople and gender non-conforming people.

239

00:48:40,667 --> 00:48:47,332

And when we talk about black, and indigenous, and other people of color, we really wanted to highlight their experiences because they are

240

the folks in our work who are going to be the most marginalized from programs.

241

They're often the people who are kicked out of programs first for being loud or...

242

00:48:57,667 --> 00:49:01,966

We've heard the term used "aggressive" when these are individuals often who have not had

243

00:49:01,966 --> 00:49:07,599

their needs met in any programs for a long time. And they finally get to a program,

244

00:49:07,600 --> 00:49:12,599

who may let them in the door, but then not treat them with respect and dignity that they deserve

245

00:49:12,600 --> 00:49:19,000

or the autonomy about their body that they deserve. And so, I really just want all of our programs to be thinking about how we can do

246

00:49:19,000 --> 00:49:28,900

this work better for BIPOC folks, and for CuTie.BIPOC folks. I'm using the word "CuTie. BIPOC", and that stands for Queer, Trans,

247

00:49:28,900 --> 00:49:33,133

Black, Indigenous, and other People of Color, but I want to ask a question about that.

248

00:49:33,133 --> 00:49:43,667

So CuTie.BIPOC, let's let's discuss the role that racism plays in in maintaining abuse in our communities, intimate partner violence abuse,

249

00:49:43,667 --> 00:49:48,899

as well, with the gueer, and trans, and black, indigenous, and other people of color.

250

00:49:48,900 --> 00:49:56,900

So, I'm going to start out that by saying the words "marginalization stress" comes to mind. So, that is when a person is experiencing

251

discrimination due to their identity. It can lower

their self esteem. It can lower their ability that their... their ability to take on their healthy

252

00:50:04,866 --> 00:50:14,666

behaviors that prevent diseases. And so, we often see individuals who are experiencing violence, who are BIPOC, experiencing much

253

00:50:14,666 --> 00:50:21,066

bigger health issues, mental health issues, physical health issues, because they're also dealing with the assault of racism, right.

254

00:50:21,066 --> 00:50:29,532

They're also dealing with the assault of patriarchy, and a colonized country, and all of the things that we deal with in this country.

255

00:50:29,533 --> 00:50:39,066

As BIPOC folks are are experiencing that, they are also trying to survive their intimate partner violence, and the violence that might be race related and intimate partner violence.

256

00:50:39,066 --> 00:50:47,132

related and intimate partner violence. So, just because we do see relationships with BIPOC folks partnered with white people,

00:50:47,133 --> 00:50:54,199

who the white person uses racism and transphobia as a unique weapon in an intimate

258

00:50:54,200 --> 00:50:59,667

partner violence that you don't necessarily see in cisgender heterosexual communities.

259

00:50:59,667 --> 00:51:08,732

Trauma paralysis, yes. From intersections of oppression, yes absolutely, great points there. Trauma paralysis like not even being... being

260

00:51:08,733 --> 00:51:14,299

able to move and do the tasks that are supposed to be completed because the oppression is coming at them from so many

261

00:51:14,300 --> 00:51:19,600

different directions. And then we get them in a program and say, okay, what's your plan to be out in two weeks? Where's your job?

262

00:51:19,600 --> 00:51:27,667

Where's your housing? All of that when we know that they're at higher risk for being turned away from housing and discriminated.

263

00:51:27,667 --> 00:51:37,667

Again, fetishes feticha... fetishization of race, as it intersects with gender as well. Absolutely. That's a great point to make.

264

00:51:37,667 --> 00:51:44,966

We know that black bodies specifically are highly sexualized from a very young age, and not seen as children, right.

265

00:51:44,966 --> 00:51:52,766

We don't even let black children grow up to be children. We don't let them be children, because the society puts such a pressure of

266

00:51:52,766 --> 00:51:59,499

sexualisation on them. And, then those individuals come out as queer that happens in the queer and trans community, as well.

267

00:51:59,500 --> 00:52:04,966

It's just all of those... all of those oppressive tactics that are happening in white communities.

268

00:52:04,966 --> 00:52:14,132

Guess what, we have a lot of racism in the LGBTQ community, anti-black racism, anti-immigrant racism, anti-native

269

00:52:14,133 --> 00:52:23,566

indigenous racism by LGBTQ folks who are white. So, it is really key for those of us in the LGBTQ community to be calling out those

270

00:52:23,566 --> 00:52:30,699

systems of violence, and to be calling out racism, and linking it to violence, like we're talking today, linking it to intimate partner

271

00:52:30,700 --> 00:52:40,033

violence, because it is... it is exactly that. LGBTQ BIPOC folks experience multiple stressors, we know that.

272

00:52:40,033 --> 00:52:45,099

They're just dealing with those constant stressors of identity and coming out

273

00:52:45,100 --> 00:52:52,667

sometimes within their own community. Are they going to be accepted within a culturally specific community that, umm...

274

00:52:52,667 --> 00:52:59,266

that is part of their family, but maybe that the entire community that they're part of doesn't have a large LGBTQ presence.

275

00:52:59,266 --> 00:53:04,999

But the large LGBTQ presence that they want to be a part of is in the white community, and yet the white community they're going

276

00:53:05,000 --> 00:53:10,833

to be discriminated against, based on their race and we hear from BIPOC survivors, all the time

277

00:53:10,833 --> 00:53:16,165

who stepped into white gueer spaces that have safe space stickers, I will add, and

278

00:53:16,166 --> 00:53:23,699

they are called slurs. They are treated in racist ways. And so just because you have a safe space sticker. Often, that means that's a safe

279

00:53:23,700 --> 00:53:34,266

place for white cisgen... or white cisgender LGB people that might present in a way that the gender does not cause

00:53:34,266 --> 00:53:42,632

transphobia to happen but it might just bring people in, who are more in the cisgender, gay, lesbian, bi community.

281

00:53:42,633 --> 00:53:49,666

And BIPOC folks know that. That that's kind of the stereotype of what has been set up as acceptable for gay and trans,

282

00:53:49,666 --> 00:53:57,499

is that what we see on, you know, back... It's not that it's a current show at all, but it's still the representation that we see on TV,

283

00:53:57,500 --> 00:54:03,566

like a Will and Grace or something like that, wealthy-white, gay people, and never talking

284

00:54:03,566 --> 00:54:07,332

about the true issues that are... that we're facing in community.

285

00:54:07,333 --> 00:54:15,667

People are marginalized in one way, are not immune to being enactors of oppression. Absolutely. Great point.

286

00:54:15,667 --> 00:54:20,266

So we can pick up the tools of the oppressor, right. We know that Audrey Lord talked about

287

00:54:20,266 --> 00:54:30,183

"We can't dismantle the Masters house by using the same tools." That's a quote is not exactly the same quote, but the survivors can

288

00:54:30,183 --> 00:54:38,299

be using the oppressors tools, as well. And, then that becomes part of... that becomes part of the... the abuse tactic.

289

00:54:38,300 --> 00:54:46,666

So there's a stereotype threat that happens, as well. Experience of anxiety or concern that this person is a black queer, a trans person has

290

00:54:46,666 --> 00:54:51,667

confirming that the negative stereotype that the rest of society already has about this community.

291

00:54:51,667 --> 00:54:55,666

And so, they may not want to seek help because they don't want to confirm that

292

00:54:55,666 --> 00:55:00,667

"Oh, I'm a black queer person who's been harmed by a black queer person."

293

00:55:00,667 --> 00:55:07,667

I don't want to confirm that, that we're violent in any way when, when violence is in all... violence does not discriminate. It's in all of our,

294

00:55:07,667 --> 00:55:15,466

of our communities, but they don't want to confirm the stereotype. And, there's a loyalty that black and brown folks and queer folks

295

00:55:15,466 --> 00:55:22,566

have to community that we don't want to... we don't want to cause like bad things to come upon our community because of something we

296

00:55:22,567 --> 00:55:29,667

may have said or may have done. And, that leaves us vulnerable in community to not be able to talk about how were harmed, as well.

297

00:55:29,667 --> 00:55:36,667

Yes, and often pressure to put one of those identities ahead of the other. Yes, that's a great point Reiko just made.

298

00:55:36,667 --> 00:55:46,199

Really, we see especially when BIPOC person is dating a white person there's that... there's that intense pressure to just focus on the gueer

299

00:55:46,200 --> 00:55:51,966

aspect of their identity and put the BIPOC part of their identity aside and not deal with it.

300

00:55:51,966 --> 00:56:04,667

In what ways... in what way... what in any way whatsoever, and I want to see what I just saw a quote that I need to go back and read here

301

00:56:04,667 --> 00:56:13,667

from... That's right I'm trying to keep people confidential so I won't say your name so just... give me a minute to look at this, okay.

302

00:56:13,667 --> 00:56:23,166

Y'all are great at discussions, which means I have to... Yes, quote unquote "master status," so only having one component of their social

303

00:56:23,166 --> 00:56:30,632

identity, race, or sexual orientation acknowledged. Absolutely, Reiko highlighted that. Thank you, Reiko for highlighting that,

304

00:56:30,633 --> 00:56:39,666

but just, again, our identities are complex. Our identities are broad, and there is just no way that we are all one thing or the other.

305

00:56:39,666 --> 00:56:47,366

We are not just all queer. We are not all just BIPOC. We have intersecting identities. It also can leave you feeling like you don't belong in

306

00:56:47,366 --> 00:56:55,032

queer in spaces as a BIPOC person or belong in BIPOC spaces as a queer person. Absolutely, Absolutely.

307

00:56:55,033 --> 00:57:03,499

This is true, and this is something that we want to highlight we see coming even with our current refugee situation. So I used to work in

308

00:57:03,500 --> 00:57:11,033

refugee resettlement. LGBTQ refugees are escaping violence in their home country, right, because of their sexual identity, their sexual

309

00:57:11,033 --> 00:57:20,199

identity, or their, you know, their gender identity, their sexual orientation, or gender identity. And they may be escaping with a group of

00:57:20,200 --> 00:57:28,266

individuals who culturally are like them, are culturally a fit for them. They may actually live in communities.

311

00:57:28,266 --> 00:57:32,132

If they're single people, and we've seen this, live... and let's just say an Afghan man,

312

00:57:32,133 --> 00:57:35,799

for example, living in a house full of other Afghan men.

313

00:57:35,800 --> 00:57:45,766

Those men might also still have a stereotype that they're bringing from a past trauma of themselves about what they believe about gay

314

00:57:45,766 --> 00:57:54,332

people. And so, that refugee in this country often doesn't feel safe coming out about their identity, because they're not going to go to the

315

00:57:54,333 --> 00:58:00,966

local gay bar, right, because that's not accepting of who they are as a refugee right here in our country, but then they need to go

316

00:58:00,966 --> 00:58:08,199

for that support within community. And, I also want to add that there are communities within our BIPOC communities, also very affirming,

317

00:58:08,200 --> 00:58:16,833

and welcoming, and of identity so this isn't... this isn't stating that BIPOC communities aren't welcome and white communities are welcome

318

00:58:16,833 --> 00:58:24,633

because racism happens in the white community, homophobia and transphobia happen in the white community, as well as, it

319

00:58:24,633 --> 00:58:36,266

does BIPOC communities. But for the individual who has both BIPOC and queer or trans, they just don't have any safe place left to turn.

320

00:58:36,266 --> 00:58:38,632

Rieko, I'm gonna hand it over to...

321

00:58:39,200 --> 00:58:42,367

All right.

322

00:58:42,367 --> 00:58:50,367

Okay, so the next question is, reflect.. so one of those survivors in the video,

323

00:58:50,367 --> 00:58:59,367

umm and, this is a quote "This is the best I can get, I might as well just put up with it, this abuse."

324

00:58:59,367 --> 00:59:09,766

And so, two-fold question. I'm wondering if we can all together reflect on what are some of the similarities and differences.

325

00:59:09,766 --> 00:59:18,899

And, why don't we just start with similarities. So what are some similarities that you might see from a cisgender heterosexual survivors?

326

00:59:18,900 --> 00:59:31,367

This idea of.. this is, this is the best I can get, I might as well put up with this abuse.

327

00:59:31,367 --> 00:59:38,166

And, I think one of the first things that comes to mind for me is that experiences of sexism and

328

00:59:38,166 --> 00:59:48,799

gender-based violence or been so normalized, right. So someone mentioned in the comments, they might be unable to see their worth.

329

00:59:48,800 --> 00:59:58,367

You know, even starting to believe that when that is the message we're given to by abusers.

330

00:59:58,367 --> 01:00:10,166

Oh, repeating the question. The question was, what are some of the similarities for cisgender and heterosexual survivors? And this is in

331

01:00:10,166 --> 01:00:20,466

reference to a quote from one of the survivors in the video who said, "This is the best I can get. I might as well just put up with this abuse."

332

01:00:20,466 --> 01:00:29,766

Yeah, so lots of... So just to summarize the comments that are coming up. Feelings of hopelessness.

333

01:00:29,766 --> 01:00:42,367

Survivors may not feel like they deserve to be treated any other way. May not believe in their own self worth.

334

01:00:42,367 --> 01:00:51,932

The other thing I... So, this... this particular quote also reminds me of... And, I think it was in a similar section of the video.

335

01:00:51,933 --> 01:01:02,799

Where a trans person was saying that they had been told by cisgender women in their life that like, well, you want it to be a woman so, like,

336

01:01:02,800 --> 01:01:12,033

this is like just part of the deal. And, that's really sad that ciswomen have that experience,

337

01:01:12,033 --> 01:01:21,367

and also very sad that it's then turned on transwomen too, right.

338

01:01:21,367 --> 01:01:29,367

Sometimes, there can be a lateral hostility and victim blaming even amongst cisgender women.

339

01:01:29,367 --> 01:01:35,367

And so that example is even like to take it further as sort of punching down.

340

01:01:35,367 --> 01:01:44,367

And again, th... it's not the fault of anyone.

341

01:01:44,367 --> 01:01:53,367

So, great. So, again, what about some of the differences that might exist.

01:01:53,367 --> 01:01:59,367

So this idea this is the best I can get, I might as well put up with this abuse.

343

01:01:59,367 --> 01:02:10,367

What might be different about that coming from an LGBTQ person.

344

01:02:10,367 --> 01:02:25,632

And, other ways that this quote might be a little bit different, coming from an LGBTQ person could be. We've already talked about this right,

345

01:02:25,633 --> 01:02:29,367

but additional layers of trauma related to someone's LGBTQ identity.

346

01:02:29,367 --> 01:02:41,367

They may have also experienced other forms of harm related to their queer trans identity and not received validation or help before.

347

01:02:41,367 --> 01:02:46,367

Someone else mentioned earlier today.

348

01:02:46,367 --> 01:02:52,466

If someone is new to an LGBTQ community or new to relationship, we have so few examples of what queer and trans relationships could

349

01:02:52,466 --> 01:03:00,367

look like. So, a survivor might think this is just what LGBTQ relationships look like, right. Like I've heard...

01:03:00,367 --> 01:03:10,566

I've heard this from survivors. A gay man who says like "I just thought that this is what a relationship between two men look like,

351

01:03:10,566 --> 01:03:16,367

because we don't have a blueprint. We don't have a roadmap."

352

01:03:16,367 --> 01:03:23,432

And, yeah, really great example in the chat. We may have even been told or raised to believe

353

01:03:23,433 --> 01:03:34,367

that LGBTQ relationships are inherently wrong or harmful so "What else should we be expecting?"

354

01:03:34,367 --> 01:03:44,199

And, yeah, these are all really great examples. I'm going to volley it over to Kathy for the next question.

355

01:03:44,200 --> 01:03:54,367

And that last point, lasting effects of the AIDS epidemic on the LGBTQ community, but specifically the BIPOC community,

356

01:03:54,367 --> 01:03:59,367

still today is is evident in the work that we're doing.

357

Just really great questions, really great... I'm sorry, really great answers to these questions

358

01:04:02,133 --> 01:04:07,533

so I wanted to make sure I highlighted as many as I could.

359

01:04:07,533 --> 01:04:17,166

So, you know, in the video, there was some talk about police violence, right. So we want to talk a little bit about... thinking about how police

360

01:04:17,166 --> 01:04:27,466

interact with LGBTQ BIPOC folks. And, how that... how well that goes, or how well that doesn't go? And, I'm going

361

01:04:27,466 --> 01:04:39,099

to kind of tie this to the question of "How does gentrification create additional barriers for LGBTQ BIPOC survivors?" And so, specifically

362

01:04:39,100 --> 01:04:46,166

now we're talking about gentrification, but I'm also thinking, you know, in that question with police involvement.

363

01:04:46,166 --> 01:04:51,299

So, one thing I want to talk about with police involvement is.

364

01:04:51,300 --> 01:04:56,133

Police are... are often much more monitoring of BIPOC communities so they're very...

365

01:04:56,133 --> 01:05:06,599

they're very reactive. They're all... they're already on the scene. And, often in white communities and gentrified communities,

01:05:06,600 --> 01:05:06,600

they're there to... for protection and support. And, you don't... you see them responding to things,

367

01:05:06,600 --> 01:05:15,733

but you don't see them, like, sitting there waiting to catch somebody doing something.

368

01:05:15,733 --> 01:05:24,399

And, and the problematic thing that happens around this is gentrification removes affordable housing, right. It was affordable housing for

369

01:05:24,400 --> 01:05:34,033

BIPOC survivors, and it removes opportunity. When we remove affordable housing and we know that the criminal... the criminalization

370

Broken window policy policing. Yes, that's a great example of that.

Another one that we see often at Diverse & Resilient, and thankfully, much less often,

But... So, another way that we program staff and shelters might gatekeep us through the screening process that filters out LGBTQ folks,

If they call and reach out, I know that some folks have already said gender segregated bathrooms, things like that.

But also, what happens if a survivor picks up the phone and frontline staff says "I'm sorry we don't serve men here."
